**BORMIO CUP
TEST RACE
BORMIO (SO) - ITALY**

October 4-5-6th 2024

The Italian Ice Sports Federation (FISG) has the honour and pleasure to invite you to the Bormio Cup Test Race OPEN which will be held at the Ice Rink Palaghiaccio Bormio – Via Manzoni – Bormio (SO) on October 4th to 6th 2024. The competition will be organized in accordance with the 2024 regulations of the International Skating Union and the conditions included in this announcement.

Entries

Entries are restricted to **only invited National Teams** whose skaters must have been born before July 1st, 2009 (i.e. who have turned 15 before July 1st 2024).

Skaters belonging to national teams born after July 1st, 2009, can be accepted sub judice provided they have qualifying times respecting World Cup 2024/2025 participation criteria.

Club skaters not belonging to national teams can also be accepted **by invitation only** provided their best times on 500m skated in season 2022/2023 and subsequent are in line with qualifying times required by World Cup 2024/2025 participation criteria.

Entries should be made on www.shorttrackonline.info; final entries closing on Friday September 27th.

Invited Italian skaters must also be entered on fisgonline; deadline is also Friday September 27th.

Entry fee

An entry fee of Euro 90.00 must be paid for every athlete and for every coach; one coach per club/nation is exempted.

Track

The track is an artificial refrigerated indoor ice surface with the measures of 30x60 meters, boardless protective padding will be in place according to ISU communication no. 2365 and subsequent. The standard track 111,12 meters to the lap with measured curves of 8,50 meters will have 7 markers used to establish the curve. The length of the straight is 28,85 m. Besides the original track there will be 7 tracks set to preserve good ice conditions. For all tracks one finish line will be used.

Qualification

- Make-up of the first qualifying round of each of the first individual distance (eg. 1500m #1) will be based on the skater's Distance World Ranking at the end of the 2023/2024 world cup season; athletes without a 2023/2024 world ranking will then be seeded according to their best times on each distance skated in season 2022/2023 or later. The make-up of the first qualifying round of the second run of individual distances (eg. 1500m #2) will be based on the distance classification of the first run (eg. 1500m #1).
- Final results from each distance will be added to determine a combined distance classification. Points will be awarded according to a custom points system adapted to the number of entries.
