Distances:

The distances will be determined based on the number of skaters and the available time.

Despite the splitted program, the organisation will do its utmost to organize 3 races for Kids On Ice and 5 races for each skater (2 distances + 1x super final).

Also it is the intention to organise a relay in the categories DEF and ABC/SEN.
